Agenda topic New Orleans Breastfeeding Center Infant Ready Program | Presenter Malaika Ludman, MPH, CLC, Doula

- Infant & Young Child Feeding in Emergencies (IYCFE)
 - Supports nutritional needs of children birth to 2 years in emergency situations where there is greater risk of malnutrition, as this is a vulnerable population.
 - Babies who receive human milk do much better than babies who do not.

- Components of the program
 - Support breastfeeding
 - Support non-breastfeeding
 - Support complimentary feeding
- Infant Ready Emergency Feeding Kits were conceived during participation in Hackathon 2018 at MIT, an easy to carry backpack contains:

Hand sanitizer	cooler bag	light
Sterilizing wipes	disposable ice packs	bottled water
Medicine cups	permanent marker	educational booklet
Breastmilk storage bags	nursing cover	face mask

- The Educational Booklet is written at a lower literacy level.
- The organization started small working with community organizations until several emergencies hit the area. During these situations, they provided:
 - o A warm-line
 - Feeding assessments using a tool adapted from a Save the Children assessment tool.
 - Formula based on need.
 - WIC was responsible for distribution of formula for those who were feeding formula.
- Lessons Learned
 - Supplies were not provided to ensure safe preparation and feeding of formula, which led to development of safer formula feeding kits with items such as: a bottle brush, hand sanitizer, 10 gal. container, medicine cups and ready to feed formula.
 - Gaps were observed in the State Emergency Response such as: there was no intake on infant feeding or documentation of families' needs; there was no formula distribution agency; powdered formula was distributed and ready to feed formula was not available for high-risk infants.
 - It would be helpful to:
 - add infant feeding questions to shelter evacuation intake forms.
 - train a team of emergency infant feeding responders to report to the shelters and assist with feeding challenges.
 - follow international guidance for formula provision.
 - develop a pre-existing, pre-approved purchase order list of infant care and safe feeding supplies to be ready upon sheltering.
 - partner with lactation care professional and birth worker organizations around the country to
 provide perinatal professionals and reciprocate services in the time of emergency.
 - Amanda Powell asked if a relationship had been established with donor milk banks to provide human milk during emergencies.
