Birth and Breastfeeding - find out official name

- Scheduled c/s may affect lactogenesis stage II
  - o No/minimal hormones of labor, longer recovery, meds, parental focus/learning impacts
- Inductions: reduced pitocin/naturally-occurring oxytocin, increased risk c/s by 2-4x, increased risk preterm/late pre-term, increased risk prolonged labor, increased epidural use, increased c/s risk
- Epidurals: 71% births in US, crosses placenta, increased risk c/s, may impact newborn behavior, increased pitocin use
  - First feed is crucial, usually w/in 1<sup>st</sup> hour. Baby becomes sleepy after 1<sup>st</sup> hr.
  - Increases use of fluids. Does this inflate initial newborn weight? Impacts feeding plans. Some hospitals now using 12-18hr weights to avoid this concern.
  - Increases risk of vacuum or forceps delivery.

- Increased risk of fever in parent.
- How to intervene?
  - Increase labor support and doulas.
  - Decrease rate and duration of epidural use. Doulas can help.
  - More education for hospital staff.
  - Better continuity of care, including written policies (including for feeding practices)
  - Community Support
